The **Master of Health Organisation Management** is a speciality in the IUP Management department at the IAE, Saint-Etienne Jean Monnet University. **Master's** equivalent of a **state diploma** recognising disciplinary and professional knowledge gained during a selective 2-year sandwich course.



Objectives

Train directors or executives from health and social establishments in different areas of management.

The course is designed to:

Develop the ability to understand and assess management situations in health organisations by combining concepts and tools from different management specialities (accounting/finance, marketing, HR management, logistics, quality, information systems, strategy etc.)

Apply management logic following operational decisions arising from strategic choices.

Develop change management skills in health organisations (new management, service fees, information system and management control, new organisation, patient relationships, accreditation, professional practice evaluation, networks etc.).

Related knowledge

The course improves skills to:

- > Manage a health organisation (in the healthcare, medico-social or social sector)
- > Design a strategy to suit evolutions in healthcare requirements
- > Recruit and run a team
- > Manage a quality system to achieve the required certifications
- > Implement logistical solutions and suitable information systems
- > Collaborate with local figures
- > Run a project and track management indicators in line with healthcare needs

Who's it for?

Target audience

> Management degree (marketing, HR, IS, quality, production etc.) one level below the entry requirement (e.g. a bachelor's degree in management to study in M1)

> A lesser degree outside management (engineering sciences, literature etc.) subject to sufficient management skills (through work experience and/or minimum attendance of management classes in initial studies.

- > Proof of sufficient management experience approved by an APEL procedure for returning students.
- > Continuing education and APEL, please contact the Continuing Education Department

Entry requirements

Admission to the M1 or M2 is based on an exam including:

- > the score from IAE-MESSAGE, except for returning students management skills
- assessement based on application form content
- > an interview

The score from IAE-MESSAGE and evaluation of the application form enable the list of eligible applicants to be drawn up.

Eligible applicants may be invited to an individual interview lasting 20 minutes.

The IAE-MESSAGE score, form evaluation and interview provide the final position.
