Objectives

The **Territorial Development Consulting Master course** (Economic Analysis and Policy studies) is a speciality in the IAE de Saint-Étienne's Economics department. State diploma equivalent to a master's degree.

The sandwich course is designed to train students in the engineering of territorial economic development. No matter the myriad assignments and roles encountered in local development sectors, development consultants must be able to manage partnerships and handle complex systems with sufficient knowledge of negotiation, communication and deductive skills.

Their role is based on the project process and ability to organise and manage group work. Please see ARADEL reference.

Available to students with:

- > a 1st year Master of Economy in Innovation and Territories studies from IAE de Saint-Étienne
- > a 1st year Master of Management Economy or Economic and Social Administration, public law, territory planning
- > a 4th year in Political Sciences (IEP)

Available to professionals in vocational retraining with a master or equivalent diploma or at least an undergraduate degree deemed sufficient by the accreditation of prior/experiential learning system.

Foreign students must prove their level of French by achieving level B2 on the DELF (French test) based on the European common framework of reference within the last two years and the DALF C1 and C2.

Calendar

Course duration: 16 months including 12 months on an apprenticeship contract.

Apprentices join an organisation to conduct projects approved by the teaching staff and have employee status earning a salary during their course year. They sign a fixed-term sandwich course contract (calendar year) on the basis of one week of classes at the university and three weeks at work per month.

Methodology, intellectual processes

Development consultants must have sound knowledge of:

- > territorial economy
- > different levels of a company's functioning (financial, socio-cultural and strategic)
- > the sequences and functioning of local authorities and their state establishments (public finances, intercommunal organisations and public authority law, inter-organisation relationships and planning policies).

Fields of application

Development consultants:

- > take part in creating territorial development policies in their economic aspect
- > manage and run the implementation of projects in their entirety or in specific fields, companies, promotion, employment, integration
